Location for photography and filming

All commercial filming and photography on Skärgårdsstiftelsen's land requires a location agreement. The location agreement does not apply to land, water, buildings, facilities or operations leased or rented out by Skärgårdsstiftelsen.

A fee is charged for commercial filming on Skärgårdsstiftelsen's land and water. The fee covers administration, invoicing, location management, information to visitors to the nature reserve, etc.

General guidelines

- Drones require a special permit from the County Administrative Board and the permit must be applied for well in advance.
The permit must be approved and submitted to us before production starts on site and must also be available for presentation there.
- The company may not restrict access to the site or remove Skärgårdsstiftelsen's staff, tenants, leaseholders or visitors from the site.
- The company must keep roads accessible to emergency and work vehicles, such as emergency services and construction machinery.

Location fee

- The location fee is SEK 10,000 per day + VAT, but may vary depending on the scale of the production and specific circumstances.

Location agreement (complete and send to Skärgårdsstiftelsen)

- This agreement does not apply to land, water, buildings, facilities or operations leased or rented by Skärgårdsstiftelsen.
- Otherwise, it applies to Skärgårdsstiftelsen's land and water areas stated in the agreement.
- Skärgårdsstiftelsen may terminate the agreement at any time without specific reason.

Consideration on site

- The company is responsible for its staff showing consideration and cooperating with Skärgårdsstiftelsen's staff, tenants, leaseholders and visitors.

Liability and insurance

- The company must hold the required insurance (Worldwide) and is responsible for all people and animals in the production on site during the period stated in the location agreement.

Nature reserve regulations and rules

- The company must ensure that staff and others involved comply with the rules of the relevant nature reserve and the Swedish Environmental Code (SFS 1998:808).
- Skärgårdsstiftelsen cannot approve exceptions from reserve rules. Written exemption from the County Administrative Board of Stockholm is required. Apply to: naturochviltarenden.stockholm@lansstyrelsen.se
- The Board decision must be sent to us before production starts and be available for presentation on site.

Barriers, access and roads

- The company may not restrict access or remove Skärgårdsstiftelsen's staff, tenants, leaseholders or visitors from the site.
- Roads must remain accessible to emergency and work vehicles, including emergency services and construction machinery.
- The company must follow rules and recommendations on vehicle axle and bogie loads.
- Driving motor vehicles off-road is never permitted.

Cleaning and restoration

- All waste must be removed from the site and may not be left behind.
 - Cleaning and/or damage to land, buildings and facilities will be charged to the company and/or reported as a breach of reserve regulations and the Swedish Environmental Code.
